DECLARATION CONCERNED WITH THE CONFORMITY TO EU-DIRECTIVES

This declaration is concerned with meeting the requirements given in legislation based on:

By joining the said organisations, attaching the required marks on and making the relevant information, about the electrical and electronic equipment she produces and sells, available, BRAVILOR BONAMAT BV. meets the legal requirements based on the EU-directive 2012/19/EU.

Since 01. April 2006 all suppliers of BRAVILOR BONAMAT B.V. have indicated that they are supplying BRAVILOR BONAMAT B.V. with RoHS-compliant materials and products, that do not contain any:

- Lead (Pb);
- Mercury (Hg);
- Cadmium (Cd);
- Hexavalent Chromlum (Cr⁶⁺;
- Polybrominebiphenyls (PBBs); or
- Polybrominediphenylethers (PBDEs).
